1. This Invitation for quotations follows the General Procurement Notice for this quotation which appeared in Procurement Journal Issue no. 1521-6021 Vol. IX – No. 38 dated 20th September, 2016.
2. The Fair Competition Commission (FCC) has set aside funds for its operation during the financial year 2016/2017. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for which this invitation for quotations is issued.
3. The Fair Competition Commission now invites sealed quotations from eligible National building and Electrical contractors registered in **Class VII or above** for the following works:
